<u>Streets – George Toth</u>

- Taylor Street Bridge Discussion. Don Black explained the annual PDOT inspection found there have been some deficiencies of the Taylor Street Bridge. PDOT has increased the frequency of these inspections. They recommend grouting and underpinning of the bridge walls. We hate to put money in to it since it is part of the Dirty Camp Run Project. The most recent inspection last month discovered more deficiencies and they are looking at various options.
- Paving Project discussion took place. Brinton Avenue and Merchants Alley are the most expensive and need the most amount of work. Brinton Ave needs a total rebuilding. It was decided to go after the LSA grant for these. The manager and engineer would prioritize the streets that can be done now and get back to Council with a list for approval.
- Discussion of placement of Speed Radar signs was discussed. It was decided to put them on the 900-1000 block of Wall Avenue and the 900 Block of Brinton Avenue.

Parks and Recreation - Debora Freeman

- The Pittsburgh Kings will hold their August 19 game under the lights. They have security guards at the games.
