Mayor Betsy Stevick

Streets - Mike Tobias

Mrs. Myers motioned to accept the lowest bid for CDBG Grant funded project, Sixth Street Sanitary Sewer Improvements, from Eveready Contracting. Total cost is \$90,865 with a Borough match of \$56,675 from the Sewer Capital Projects Fund. Seconded by Mrs. Galia; motion carried unanimously.

Mr. Tobias described a successful volunteer event with thirty Pitt students cleaning up town, working in the memorial garden. He thanked Lisa Petrosky, Fox's Pizza, Virginia and Doug Crothers and the Fire Company for their assistance.

Parks and Recreation – Cammeo Farally

Mrs. Farally thanked everyone who volunteered for and participated in the Harvest Festival.

Finance and Economic Development – Jim Rullo

Mr. Dick motioned to adopt Resolution 50-2019 authorizing WPJWA as billing agent for the Borough to increase the ALCOSAN portion of waste water treatment by 7% in 2020 to reflect ALCOSAN's increase. Seconded by Mrs. Myers; motion carried unanimously.

<u>Health and Welfare – Kevin Dick</u>

Mr. Dick motioned to award contract to lowest bidder for trash collection and door-to-door household hazardous and e-waste collection. Seconded by Mrs. Galia. Question on the motion: Mrs. Myers asked for clarification. Mr. Dick: Waste Management was the lowest bidder. He recommends approving the one year option and see how they do.
